We wish to inform that the Board of Directors at their meeting held today have recommended the continuation of the directorship of Mr. M Lakshminarayan, Independent Director who completed the age of 75 years on 7<sup>th</sup> September 2021.

He was a Government Appointee as the Chairman of the Research Advisory Board of Central Manufacturing Technology Institute, Bangalore. He is a Member of the Board of Directors in several listed companies which includes Kirloskar Oil Engines Ltd, Wabco India Limited, ASM Technologies Limited, Suprajit Engineering Limited and TVS Electronics Limited. He is at present the Chairman of Wabco India Limited.

Mr. Lakshminarayan is not debarred from holding the office of Director by virtue of any SEBI order or any other such authority.
