We wish to inform you that the Board at its meeting held today appointed Mr. Amit Ingale as Executive Director & Chief Executive Officer of the Company for a term of five years commencing from 19<sup>th</sup> January 2026, subject to the approval of shareholders. He will also be one of the Key Managerial Personnel of the Company pursuant to Section 203 of the Companies Act, 2013 with effect from 19<sup>th</sup> January 2026.

In terms of Section 196 of the Companies Act, 2013, approval of shareholders is required for the appointment of an Executive Director on the Board of the Company. In line with the same and as per Regulation 17(1C) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Board has recommended seeking the approval of the shareholders via Postal ballot for appointment of Mr. Amit Ingale as an Executive Director for a term of five years commencing from 19<sup>th</sup> January 2026.

Mr. Amit Ingale is not related to any Director of the Company and is not debarred from holding the office of Director by virtue of any order passed by SEBI or any other such authority.

The above appointment has been considered and recommended by the Nomination and Remuneration Committee at its meeting held prior to the Board meeting. The requisite details with respect to the changes under Regulation 30 read with Para A (7) of Part A of Schedule III of the Listing Regulations and SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated 11<sup>th</sup> November 2024 are provided in Annexure to this letter.
